

Autism Spectrum Australia (Aspect)'s Board and management place importance on high standards for ethical behaviour, governance and accountability in Aspect's day to day operations and business. The organisation is:

- a company limited by guarantee;
- operating as a not-for-profit charity with public benevolent institution and deductible gift recipient status.

Governance Framework

The organisation is governed by Aspect's Constitution, which is approved by Aspect's Members, and the Regulations of Aspect, which are approved by the Aspect Board.

The Board's governance responsibilities are further elaborated in the Aspect Board Charter which clearly articulates the roles of the Board and Management, as well as key Board and Board committee administrative processes.

Board Directors and office bearers have a Position Profile and agree to adhere to the Aspect Board Code of Conduct. These documents provide a broad framework of ethical conduct and outline the standards of conduct and performance expected of Board Directors associated with their role with Aspect.

The Charter and Code of Conduct are approved by the Board and are based on the requirements identified in Corporations law, the ACNC Governance Standards, Aspect's Constitution, the Regulations of Aspect, as well as other best practice standards for Boards and principles agreed to by the Board in its operation. They are regularly reviewed and available to all stakeholders on the Aspect website.

Finally, Aspect provides clear communication and effective guidance to all staff in decision making, evidence-informed contemporary practice, conduct and processes by developing, reviewing and approving policies in accordance with the Aspect Policy Framework, which aligns to the relevant state and federal standards and legislation for Aspect services. Aspect policies are available in standard and Easy English on the Aspect website.

Board Structure

The Board Charter outlines the structure of the Aspect Board. The Board is supported by three committees, these being the:

- Finance, Audit & Risk Committee;
- Governance Committee; and
- Education Strategy and Oversight Committee (until 2024).

Aspect Advisory Council

Integral to Aspect's governance is the Aspect Advisory Council which comprises up to nine Autistic adults. The Council provides direct advice to the Board and the Aspect Executive on Aspect's governance, strategy and risk, based on their lived experience.

Each Board committee and the Council have a Terms of Reference.

Compliance with ACNC Governance Standards

As a charity registered with the ACNC, Aspect demonstrates compliance with the ACNC Governance Standards.

Standard 1: Purposes and not-for-profit nature

The Aspect Constitution outlines Aspect's charitable purpose within its Objects (Clause 4) and defines its Non-profit status (Clause 27).

Standard 2: Accountability to members

Clauses 5.1 – 5.8 and Clause 6 of the Constitution and Clause 1 of Aspect's Regulations pertain to Aspect's Members. Aspect invites Members to nominate for the Board annually and to attend the Annual General Meeting where they can be involved in any decisions taken and receive a copy of the Annual Report. The Annual Report is also available on the Aspect website and can be sent to Members on request.

Standard 3: Compliance with Australian laws

Aspect is committed to complying with Australian laws. It does so through a comprehensive governance framework as outlined in this policy.

Standard 4: Suitability of Responsible People

The Board Code of Conduct articulates the relevant statutory bodies for which Aspect Board Directors are a "responsible person" or equivalent. Aspect has procedures in place and takes all reasonable steps to be satisfied that its Board Directors continue to meet the requirements of all relevant statutory bodies.

Standard 5: Duties of Responsible People

The standards of behaviour articulated in the Board Code of Conduct, to which Aspect Board Directors are held to account, align with the duties required by Standard 5.

Standard 6: Maintaining and enhancing public trust and confidence in the Australia not-for-profit sector

Aspect is a participating non-government institution of the National Redress Scheme for Institutional Child Sexual Abuse Act 2018 (Cth) (Redress Act) as required by Standard 6.

Governance Reporting

Aspect maintains all governance, fundraising and financial compliance related reporting as required by federal, state and territory governments' regulation of charitable organisations.
