# User Guidelines

**Aspect is a registered provider of support services to NDIS participants.**

We offer services in the following Registration Groups:

- Group 104: **High Intensity Daily Personal Activities**
- Group 107: **Daily Personal Activities**
- Group 125: **Participation In Community, Social And Civic Activities**
- Group 136: **Group And Centre Based Activities**

Each Group has

- a number of support services and the rate for each service is priced separately by the NDIS.
- a support purpose of **Core** or **Capacity Building**.

Different pricing models apply depending on the location of the service requirement.

The pricing models are determined by the Modified Monash Model (MMM).

For further information on the MMM model, please refer to the NDIS Price Guide 2020-21, page 12.

Aspect's location pricing models are as follows:

**Non-remote locations (MMM 1-5)**

**Remote locations (MMM 6)**

**Very remote locations (MMM 7)**

The pricing models apply to **face to face individual and group services** as well as **non face to face (administration) services**. They also apply to some of our non NDIS services.



# User Guidelines

**Shadow Fees** (complex individual support needs) and **Establishment Fees** (support for new participants, changing providers), are not included in this pricing list as they are agreed with the participant and Aspect Adult Community Services.

For more information on these fees, please refer to the NDIS Price Guide 2020- 21, page 25.

Aspect Adult Community Services applies conditional loading called a **Temporary Transition Payment (TTP)** for certain support items. The letters **TTP** appear in the relevant support items pricing description.

Aspect Adult Community Services claims 100% of the agreed fee for appointment cancellations received at short notice. A cancellation is a **short notice cancellation** when:

- the participant is not present for the scheduled session (no show)
- less than 2 business days notice of the cancellation is given to Aspect Adult Community Services.

Short notice cancellation claims are discussed and noted in the service agreement.

Please note: fees will vary in accordance with changes and adjustments to the NDIS prices.

# Notes on Travel Charges

**As stated by the NDIS, travel is to be charged.  
All Aspect Community Services participants will be charged per day for transport to access community and recreation activities.**

As per the NDIS travel guidelines, travel is charged as a rate of \$19.50 per day.

All travel is negotiated as part of the Service Agreement.

Our travel charges remain in line with or are less than those recommended by the NDIS.





# Coronavirus (COVID 19) response
